AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR CEDAR CREEK VILLAGE I

THIS AMENDMENT is made this 28th day of October, 1991, by Cedar Creek Properties, Inc.

BACKGROUND STATEMENT

WHEREAS, Cedar Creek Properties, Inc. ("Declarant") executed that certain Declaration of Covenants, Conditions, and Restrictions for Cedar Creek Village I which was recorded on July 3, 1989, in Volume 3012, Page 124, et seq., of the Johnson County, Kansas public records and which covered certain property described on Cedar Creek Village I, First Plat, recorded on March 15, 1989, at Volume 72, Page 22, ("Declaration");

WHEREAS, additional property has been made subject to the Declaration by certain Supplemental Declarations recorded in the Johnson County, Kansas, public records, which property is more fully described in Exhibit "A" attached hereto; and

WHEREAS, the Declaration was amended by that certain Amendment to the Declaration of Covenants, Conditions and Restrictions for Cedar Creek Village I which was recorded on April 2, 1991, in Volume 3326, Page 311 et seq., of the Johnson County, Kansas public records and which covered property more fully described in Exhibit "A" attached hereto; and

WHEREAS, Article XIII, Section 2, of the Declaration provides that such document may be amended unilaterally by the Declarant, provided that the amendment has no material adverse effect upon any right of any Owner;

WHEREAS, the following amendment to the Declaration does not have any material adverse effect upon any right of any Owner;

WHEREAS, the Declarant has approved the following amendment to the Declaration;

NOW, THEREFORE, the Declaration is hereby amended as follows:

Article XII, Section 4, of the Declaration is hereby deleted in its entirety and the following is substituted in its place:

Section 4. Animals and Pets. No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any portion of the Village Properties, except that dogs, cats, or other usual and common household pets may be permitted in a Unit up to a maximum number as determined by the Board but not to exceed the maximum number allowed under City of Olathe ordinance, and horses may be permitted in certain Neighborhoods designated by Declarant or the Board.

However, those pets which are permitted to roam free, or, in the sole discretion of the Association, endanger the health, make objectionable noise, or constitute a nuisance or inconvenience to the Owners of other Units or the owner of any portion of the Village Properties shall be removed upon request of the Board; if the owner fails to honor such request, the pet may be removed by the Board. No pets shall be kept, bred, or maintained for any commercial purpose. Dogs which are household pets shall at all times whenever they are outside a Unit be confined on a leash held by a responsible person.


